Focused on win-win solutions to make our energy, buildings, and transportation sectors sustainable, resilient, and more equitable



A Resilient Future for Coastal Communities Federal Policy Guiding Principles



- Federal policies and programs must be designed and implemented based on the climate
 of the future rather than the climate of the present or past.
- Climate justice and equity must be fully embedded into new policies and programs and incorporated into ongoing efforts.
- The federal government should take a leadership role in connecting science with practice, and support and expand collaborations with state, local, and tribal efforts.
- The federal government should take a leadership role to ensure that intra- and interagency coordination helps states, local governments, and tribes to access available coastal resilience resources.
- Federal investments in coastal communities must be leveraged to create local jobs and help develop a workforce trained in adaptation and resilience.
- Climate adaptation and resilience work should complement and, when possible, contribute to a decarbonized, clean energy economy.



Someone who integrates projections about future climate conditions into their day to day work.





Putting people and communities on the front lines of climate change first, always.


- Those who experience the consequences of climate change first and worst.
- People who are highly exposed to climate risks and have fewer resources, capacity, safety nets, or political power to respond to those risks because of discrimination.
- Including, but not limited to: **Black people, Indigeonous Peoples, people of color, people with low incomes** and from low income backgrounds, immigrants, those at risk of displacement, old and young people, people experiencing homelessness, outdoor workers, incarcerated people, renters, people with disabilities, and chronically ill or hospitalized people.

Federal policy changes needed

Reform **Transform Fund**

Fund the actions we know we need

- → More federal dollars for adaptation & resilience
- →Put impacted people in control of how money is spent
- → Cut red tape for funding to ensure equitable access



Reform existing policies to avoid maladaptation

Maladaptation

"...actions that may lead to increased risk of adverse climate-related outcomes, increased vulnerability to climate change, or diminished welfare, now or in the future"

(IPCC Fifth Assessment Report, WGII)

- → require use of forward-looking climate information
- → Ask: where are benefits and risks going?



Transform

→ Accept emerging new realities

→Envision where we want to go

→Enact new policies to get there



Federal policy changes needed

Reform **Transform Fund**

Where to start? ASAP Policy Priorities for 2021

- → Create Federal standards for climate data and mandate use of future climate projections in agency decisions.
- → Treat climate change as a crisis and prioritize justice and equity in crisis response
- → Overlay climate resilience needs on all infrastructure decisions
- → Preserve and manage natural systems for climate resilience
- → Define, develop, and train the climate change adaptation and climate resilience workforce
