# Environment & Energy Congressional Round-Up | March 4 - March 8, 2024

# **Highlights:**

This week, three FY 2024 appropriations bills (<u>H.R.4366</u>) were presented to the president, including the *Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations Act, 2024*; and the *Transportation, Housing and Urban Development, and Related Agencies Appropriations Act, 2024*.

Also this week, the *Radiation Exposure Compensation Reauthorization Act* (<u>S.3853</u>) passed the Senate. Sponsored by Sen. Josh Hawley (R-Mo.), the bipartisan bill would improve compensation for victims of radioactive exposure, including for those exposed to uranium mining waste and Manhattan Project waste.

Rep. Seth Moulton (D-Mass.), along with 26 other cosponsors, introduced the *American High Speed Rail Act* (H.R.7600), a bill that would invest in building a national high speed rail system, including \$41 billion in annual funding for high and higher speed rail.

Finally, the Environment Subcommittee of the House Committee on Science, Space, and Technology held a hearing titled <u>Winning in Weather: U.S. Competitiveness in Forecasting and Modeling</u>. EESI's recent <u>briefing</u>, <u>Innovations in Weather Forecasting for a Changing Climate</u>, explores how effective forecasting and communication can help communities predict and prepare for extreme weather events.
