# Environment & Energy Congressional Round-Up | November 13 - November 17, 2023

# Highlights:

Sen. Ed Markey (D-Mass.) and Rep. Nydia Velazquez (D-N.Y.), alongside Democratic cosponsors, reintroduced the *Climate Displaced Persons Act* (<u>S.3340/H.R.6455</u>). This bicameral bill establishes new protections for people displaced by climate disasters abroad, as well as immigration pathways to the United States.

Reps. Zachary Nunn (R-Iowa), Nikki Budzinski (D-III.), and Derrick Van Orden (R-Wis.) introduced the *Agricultural Biorefinery Innovation and Opportunity (Ag BIO) Act* (<u>H.R.6413</u>). The bill increases grant funding from the U.S. Department of Agriculture to bolster innovations in <u>biofuels</u> and other bioproducts.

Sens. Gary Peters (D-Mich.) and Pete Ricketts (R-Neb.) introduced the *Supporting Trucking Efficiency and Emission Reductions (STEER) Act* (<u>S.3315</u>). The bipartisan bill establishes a voucher program to make emissions reduction technologies for Class 8 trucks more accessible and affordable. EESI's related <u>fact sheet</u> discusses the benefits and feasibility of semi-truck fleet electrification.

The Senate Committee on Environment and Public Works concluded a <u>hearing</u> on the climate and economic benefits of industrial decarbonization, as well as opportunities to grow the sector. The industrial sector, including the production of building materials, is responsible for a large portion of carbon dioxide emissions. EESI's article, <u>Achieving</u> <u>Sustainability in the Built Environment</u>, <u>Brick by Brick</u>, explores ways to reduce carbon dioxide emissions from building materials.
